Pricing Data – Valuation and Transaction of Security

Stock (North America)

CRSP: Price, Return, Volume, and Market Capitalization - Daily and Monthly *TAQ*: High Frequency Trading Data – Intraday *Intraday Indicators by WRDS*: Intraday Indicators pre-calculated using TAQ *Markit Security Finance*: Short Selling data

Stock (Global)

Compustat Global: Price, Return, Volume and Market Capitalization

FactSet, TR WorldScope

Pricing Data – Valuation and Transaction of Security, Cont.

Derivative

OptionMetrics: Prices, Volumes, and Implied Volatilities, Greeks, US and Europe *Markit*: CDS data

Fixed Income

TRACE: Bond prices, trading volume *Mergent FISD*: Bond characteristics, rating *WRDS Bond Returns*: pre-calculated bond returns based on TRACE and FISD *MSRB*: Municipal Securities Transaction Data *TR DealScan*: Commercial loan pricing data

Fundamental Data - Extracted From Financial Statements:

Balance Sheet, Income Statement, and Cash Flow from 10-K, 10-Q, 8-K

Compustat – NA, FactSet, Capital IQ, WorldScope

Financial Ratio Suite by WRDS – pre-calculated metrics using COMP at firm and industry level

International Fundamental Data:

Compustat – Global, FactSet, WorldScope World Indices by WRDS: global market indices based on Compustat Global data Bureau van Dijk – Orbis: global public and private companies

Fundamental Data - Extracted From Financial Statements: Cont.

Secondary Data:

Segment Data: Geographical, Industry, Customer (Compustat or FactSet Revere)

Corporate Event Data:

- Capital IQ Key Developments date and key events (e.g. delayed filings, rating change)
- RavenPack Timestamp and headlines of macro and company specific news
- TR SDC M&A and New Issues (IPO SEO)

Earnings and Estimate

I/B/E/S – Analysts forecasts, Guidance, Actual earnings

- US data starting 1975
- International data back to 1987

Zacks - analysts' forecasts and their revisions, price targets and recommendations



Institutional Ownership Data

Thomson-Reuters 13F Ownership Data (legacy SP feed)

- S34 Data, with history starting in 1980
- Formerly known as CDA Spectrum

Thomson-Reuters Global Ownership Data (OP feed)

- Institutional (Type 2) Data, consistent history from 1999
- US 13F data + non-US aggregated institutional data

Factset 13F Ownership Data (formerly LionShares)

WRDS – SEC 13F Data

• Complete history from June 2013, including original filings & amendments

Fund Ownership Data

TR Mutual Fund Data (legacy SP feed)

• S12 Data, equity holdings every fiscal quarter end from 1980

TR Global Ownership (OP feed)

- Mutual Fund (Type 3), starting from 1999
- US + non-US fund ownership of US and Global equity securities

Factset Fund Ownership Data (formerly LionShares)

CRSP Mutual Fund Database (CRSP MFDB)

- Returns, NAV, expense ratios, loads, 12b1 fees, investment obj, etc
- Holdings available from 2003 and reliable only after June 2010

TR Insider Data

• Stock (Table 1) and Derivative (Table 2) from 1986

WRDS-SEC Insider Data

- Complete Stock and Derivatives history from 2003 + original filings & amendments
- Footnotes (e.g. 10b5, hedges/swaps etc) + detailed filing contents

Audit Analytics Shareholder Activism Data

Executive and Director Ownership Info:

- Comp ExecuComp from 1992-present
- ISS (formerly Risk Metrics, IRRC) for ownership by board members, from 1996
- BoardEx for officers and directors' ownership from 1999 US and Global

- Hedge Fund Research



Other Tools – WRDS Linking Suite

- Bond CRSP Link allows users to directly link fixed income data at the individual bond level to the equity data from the CRSP database.
- BoardEx CRSP Compustat Link provides the link of Boardex companies with CRSP-Compustat universe
- CRSP Compustat Link by CUSIP SAS code allows users to link CRSP
 PERMNO with COMPUSTAT GVKEY by CUSIP
- FactSet CRSP Link links Factset's security id as well as entity id with CRSP identifiers
- IBES CRSP Link provides the historical matching of IBES TICKER with CRSP PERMNO.
- Option Metrics CRSP Link provides the link between OptionMetrics
 SECID and CRSP PERMNO
- TAQ CRSP Link provides the link between TAQ SYMBOL and CRSP
 PERMNO
- TR Insiders Boardex Link provides the link between TR Insider PERSONID and Boardex DIRECTORID.
- Compustat Customer Segment Company Names - GVKEY Link provides the missing link between abreviated Customer Segment (Supply Chain) Company Names to GVKEY.
- Federal Judicial Center Litigation Compustat-CIK Link provide the link among Docket Numbers, Case keys, GVKEYs and CIKs. Link is provided for Bankruptcy, Civil and Criminal data.
