### USE CASE SCENARIOS

- Use cash flow modelling to gauge the specific timing, size and frequency of drawdowns and distributions from private capital funds, in order to model cash flows for investors compared to other asset classes.
- Benchmark the performance of a custom group of private capital funds in order to look at the returns made in specific regions and/or industries. Compare these benchmarks to other industries and asset classes, or to public markets.
- Collect information on fundraising and deal making activity in specific sectors and geographies, and see how industry assets have grown in size over time.
